Application

KENT Urea Anti Crystal Additive in AdBlue® tank at refill (proportion of 0,25%) will clean urea injectors and tank therefore prevent breakdowns due to crystals contamination.

Crystals can appear from Urea when outside temperature is cold (circa -10° c) or if the exhaust gases temperature is not sufficient for the redox reaction to be complete.

This product also dissolves crystals on parts contaminated by urea crystals by direct application.

Instructions

- 1. Define how many liters of AdBlue® are filled in urea tank of the vehicle
- 2. Calculate needed quantity of additive (proportion is 25ml of additive for 10 liters of urea solution).
- 3. Loosen the cap with a quarter turn.
- 4. Fill metering head by pressing the bottle, open cap and pour content into urea container prior filling the AdBlue®.

Caution: never put Urea Anti Crystal Additive in fuel tank. To be added into AdBlue® tank only.
