


# **Refresh One Shot**

# Application

A powerful high quality aerosol spray which deodorises and refreshes the air conditioning system in vehicles. Effectively refreshes the evaporator of the vehicle's air conditioning system.

## Instructions

The car should be clean inside and the air conditioning evaporator should be dry.

- 1. Start the engine, switch off the air conditioning and set the air flow on recirculation position adjusted to full power and cold temperature.
- Place KENT REFRESH ONE SHOT on a piece of newspaper or cardboard in the intake area of the footwell (in most cases) on the passenger side, activate the aerosol and close the door.
- 3. When aerosol has emptied allow engine to run for a further 5 minutes.
- 4. Switch engine off, open windows and allow the car to ventilate for 30 minutes.

#### Attention:

Don't smoke in the vicinity of or inside the vehicle before, during and immediately after application. The product contains flammable components. Don't treat the vehicle in enclosed spaces, e.g. garage. Danger of poisoning by exhaust gases! Oversee vehicle during use. Use only 1 aerosol can per vehicle treatment.
